Significant flooding was reported around the city of Roanoke. Several streets became impassable with a foot or more of water flowing over them, and several homes in the area got up to 3 feet of water in them. The hardest hit area was along AL-22, near Midway Full Gospel Church. At least one unoccupied vehicle was carried about 400 feet down a flood swollen creek, and an additional vehicle in the same area was submerged for a time. One person had to be rescued from her trailer after flood waters surrounded it.
