95 locations reported rainfall for the month of August, for an average of 1.00".

Normal August precipitation for Midland International Airport is 1.77". Total precipitation for Midland International Airport for the year ending September 1<sup>st</sup> was 10.56", or 1.14" above normal.

Despite August's benign rainfall, most of the HSA remains out of drought. Only the northwestern half of Eddy County remains abnormally dry, with the extreme northwest portion in moderate drought.

Reservoir levels across the HSA averaged 38% of conservation capacity at the end of August.
