Normal April precipitation for Midland International Airport is 0.73". Total precipitation for Midland International Airport for the year ending May 1st was 0.11", or 2.15" below normal.

With such meager rainfall during April, the drought continues to worsen. As of May 1st, a large swath of West Texas, extending from Valentine to Midland, was in exceptional drought. The rest of West Texas and Southeast New Mexico were in extreme drought.
