Normal April precipitation for Midland International Air and Space Port is 0.65". Total precipitation for the airport for the year ending May 1st was 4.83", or 2.31" above normal.

Due to April showers, drought conditions have improved across the area. In Southeast New Mexico, most of Eddy County west of the Pecos remains abnormally dry. The rest of Southeast New Mexico remains out of drought. All of West Texas is now out of drought.
